## **NOTIFICATION**

No. MBOCWWB/MED/12: Whereas in pursuance of the approval accorded by competent authority of the Board, a verification committee was constituted to examine the form submitted by the Labour Card Holder for claims under Medical, Maternity and Accident scheme vide Order No. 19/12/2020.

And whereas, Manipur Building and Other Construction Workers Welfare Scheme 2016 provides for "Medical Expenses for treatment of Major ailments (i.e. suffering from T.B., Cancer, Heart Disease, Kidney Disease, Eye Disease, Leprosy, HIV Disease and Nerve Disease) of the beneficiaries and their spouse or children "

And Whereas, the Committee in a span of 2 (two) weeks examined 1336 forms and identified 1044 claims are found to be considered under Medical benefit ,196 claims are found to be considered under Maternity Benefits and 96 claims are to be considered under Accident benefits.

And whereas, for the form under Medical benefits, the committee identified the eligibility in respect of documents like labour card no., the claim amount, relationship etc under the scheme, and provisionally rejected 65(sixty five) forms for want of documents.. However, the committee was not able comment on the eligibility of the claim in terms of the ailment as Medical expert opinion was required.

And whereas, it was found the 76(seventy six) forms under Maternity and 34 (thirty four) forms under Accident were rejected as the claims for Maternity and Accident benefits are only given to Labour Card Holder and not to dependents as per the Scheme notified and for other reasons .

Now therefore, it is hereby notified for information to all the concerned that , 979 (nine hundred and seventy nine) applications are notified under Medical Claims **subject to certification of the ailment as eligible under the scheme by Medical Department as listed in Annexure I**. Claims of 65 under Medical Benefits are provisionally rejected as listed in Annexure II, claims and objection if any may be submitted by the concerned in writing to the undersigned within 15 (fifteen) days from the date of Notification.

- 120 Beneficiaries under Maternity Benefits is listed as Annexure III and 76 claims are provisionally Rejected as listed in Annexure IV, claims and objection if any may be submitted by the concerned in writing to the undersigned within 15 (fifteen) days from the date of Notification.
- 62 beneficiaries under Accident Benefits is listed as Annexure V and 36 claims are provisionally rejected is listed as Annexure VI claims and objection if any may be submitted by the concerned in writing to the undersigned within 15 (fifteen) days from the date of Notification.

Further, the list so notified above is subject to deletions of duplicate entries/ forms and duplicate Account Number and earlier release if any at the time of Direct Benefit Transfer (DBT).

Remaining forms if any, shall be verified and notified subsequently.

This issues with the approval and direction of competent authority of Manipur Building and other Construction Workers welfare Board.
